

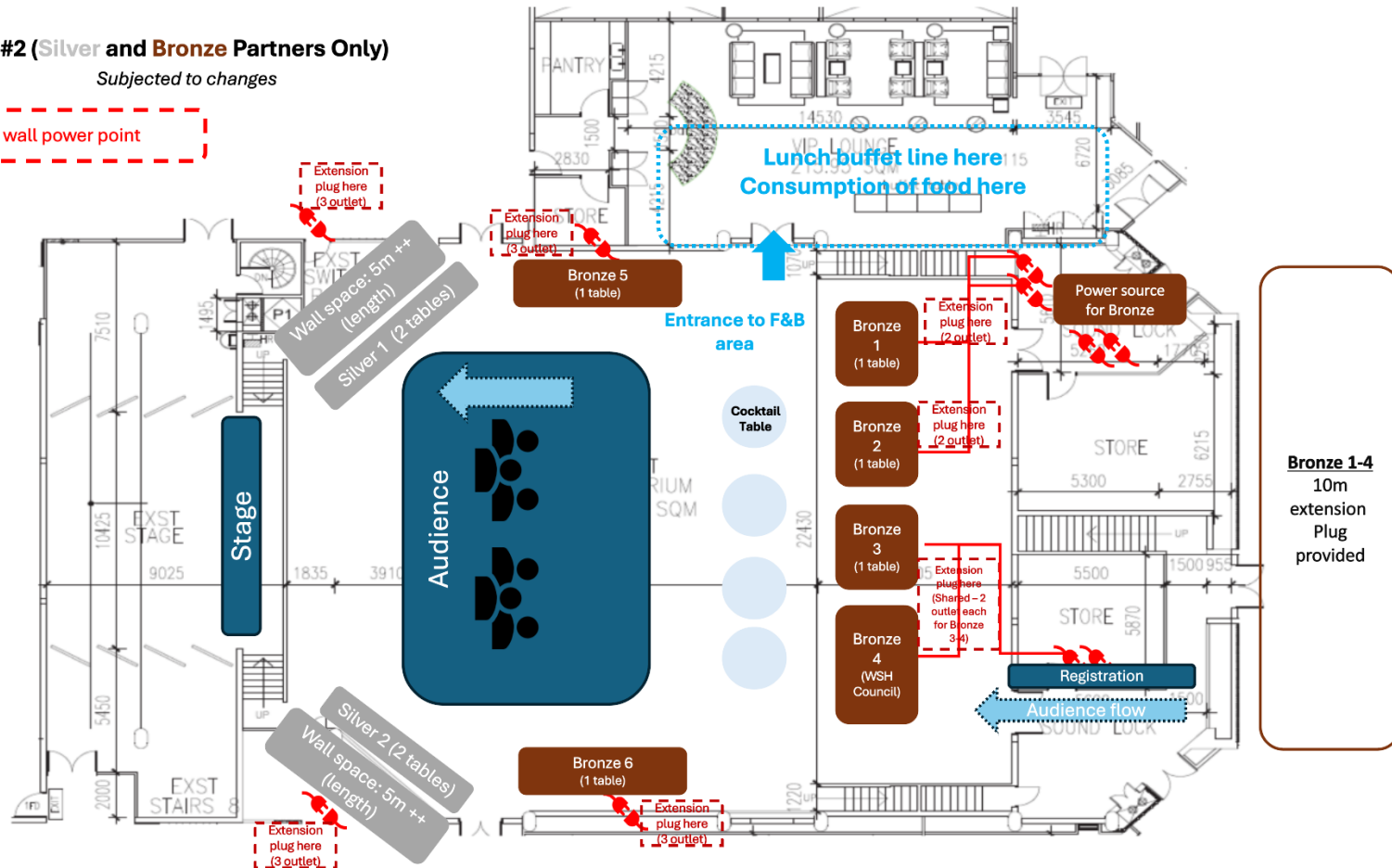
Layout #1 (Gold, Silver and Bronze Partners) Subjected to changes
